Dear Parents/Caregivers,

On **Thursday 10<sup>th</sup> December 2020 Stage 3** students will be going on an excursion to **Trees Adventure Grose River Park, Yarramundi**. Using nature as a learning space, students will develop their interpersonal skills and resilience. They will apply movement skills to a variety of physical activity contexts and assess and apply solutions to movement challenges.

Students will be travelling by bus and are **required at school by 9:00am sharp**. The bus will be **leaving at 9:15am** and due to the scheduling of the day, we are unable to wait for anyone who is late. Students will be **arriving back at school at approximately 2:45pm**.

Students are to **wear their full school sports uniform** including strong, sturdy sports shoes and a school hat. Gloves will be provided, however students are welcome to bring their own if they choose to. Students are asked to **pack food for crunch and sip, recess and lunch, along with plenty of water** for the day as bubblers at the venue will not be in use. Please remember to label everything with your child's name.

The cost for the excursion has been subsidised, with cost of travel being paid by the school. The cost for each student is **\$29.00**. Please complete and return the permission slip and Trees Adventure Waiver Form with payment, by **Wednesday 2<sup>nd</sup> December 2020**.


Parents experiencing financial hardship are encouraged to make an appointment with the Principal to discuss payment options. All such requests are treated confidentially.

# PARTICIPANT DECLARATION

Trees Yarramundi Pty Ltd ABN 42 620 193 400 (TA)

In consideration of, and as a condition of my participation in the TA Tree Top Obstacle Course in Grose River Park (Course), I acknowledge and agree as follows (for participants under 18yo, a parent/guardian must also acknowledge and agree):

## Rules of participation

1. I will follow any rules, directions and/or instructions set by or from TA (or its agents) in connection with the Course (rules). If I fail to comply with these rules I will not be permitted to participate or to continue to participate in the Course. ## Risk Warning

2. The Course is inherently dangerous and involves risks, including but not limited to undertaking an activity at a height of up to 15m in trees in a forest environment and to branch falls. Accidents can happen. I understand not all risks can be predicted. I may face harm by participating in the Course which may result in personal injury, death or property damage.

## Waiver

3. I agree and undertake any such risk voluntarily and at my own risk. I acknowledge that the assumption of risk and warning above constitutes a 'risk warning' in accordance with relevant legislation. As a supplier of recreational services TA may ask me to agree that the statutory guarantees under the Australian Consumer Law in Schedule 2 to the Competition and Consumer Act 2010 (Cth) (ACL) do not apply to me (or a person for whom or on whose behalf I am acquiring the services or activities). 4. By agreeing to these terms and conditions, I agree that those statutory guarantees do not apply to me. I understand that this means my rights (or the rights of a person on whose behalf I am acquiring the services) to sue TA in relation to the recreational services that I undertake because the services or recreational activities provided were not in accordance with those guarantees are excluded, restricted or modified as set out below.

## Release and indemnity

5. Save that the below releases and indemnities shall not apply to the extent that the loss, damage or injury that is the subject of the Claim is caused or contributed to by the gross negligence of TA, I:
  - a. release and will release TA from all Claims that I may have or may have had but for this release arising from or in connection with my participation in the Course; and
  - b. release and indemnify TA against any Claim which may be made by me or on my behalf for or in respect of or arising out of my death whether caused by the negligence or breach of contract by the TA or in any other manner whatsoever; and
  - c. indemnify and will keep indemnified TA to the extent permitted by law in respect of any Claim by any person:
    - i. arising as a result of or in connection with my participation in the Course;
    - ii. against TA in respect of any injury, loss or damage arising out of or in connection with my failure to comply with TA's rules and/or directions.

**Claim** means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising including but not limited to negligence, (but not gross negligence) by any person expressly entitled to make a claim under any applicable insurance policy.
