Congratulations, your child has shown interest to represent our school by becoming a member of the 2024 Stage 2 Dance Group. This is a Student Interest activity under the High Potential and Gifted Education (HPGE) policy for the NSW Department of Education NSW. This dance group embodies Leura Public School's dance students from Years 3 and 4. This is a large commitment for both you and your child for the **whole year** if you accept your child's interest.

This year the Stage 2 Dance Group will be auditioning for external performing arts festivals including Synergy Dance Festival and Blue Mountains/ Nepean Dance Festival.

2024 Dance Group members and parents/carers will be asked to commit to the attached agreement. This agreement entails your child's commitment to the group for the year and the payment of costume costs. Dancers are expected to attend all rehearsals and performances. The estimated cost for costuming in 2024 is between \$50 and \$70. The school will always source costumes from reputable suppliers and check that costume appropriateness adheres to policies of various festivals. The costume will need to be kept for the entire year as we will be performing at various events in the year and at the end-of-year functions. The costumes become your property to keep at the end of 2024.

Please note that some performances will be photographed and/or videoed and these may appear as advertising material or be made available for purchase by parents. Please contact the school if you would like to discuss this.

This will enable rehearsals to commence immediately as auditions for the stated events are expected in the next couple of months.
